a. Ideas for Budget

Nita handed out a spreadsheet of past spending and what the future looks like. The budget doesn't look great, because have been using SPED carryover for the last several years and that has now been depleted. Admin is super healthy and has three months of operating; which is first time in several years that has happened. Suggestions that are going to be made to the Superintendents to help the SPED budget is to split Nita's salary 50/50 between admin/SPED, increase assessments by a total of \$40,000 to be split between the 14 districts, letting districts be responsible for their own para's, look at expensive services that can possibly be dropped. Not really a way to cut staff as most staff positions are mandatory. Wil be asking for a salary increase for all staff of 1% on the base plus a step, except for paras/secretaries, they will be higher in order to meet minimum wage. Will also ask for an increase in mileage from 40 cents/mile to 42 cents/mile. Nita will also be asking for a 14 month contract, because it will be her final year. With a 14 month contract she will work an additional 2 months for training purposes. The ultimate goal is to get expenditures and revenues to match.

Nita also let the board know that on the afternoon of March 12, Dale with the Colorado BOCES Association will be meeting with the Superintendents to discuss how to proceed with Nita's replacement.
